City of Crescent Springs

DATA: The City of Crescent Springs is located in Kenton County, approximately 6 miles south of Cincinnati, OH on I-75, within 2 miles of I-275, and is 14 miles east of the CVG Airport. The 2010 census reported total population of 4,073 living within the 2 square miles of land that makes up the city. Daytime population is much higher due to the number of businesses within the city.

GOVERNMENT: Crescent Springs is a Home Rule City with a Mayor/Council (six members) form of government and non-partisan elections, chartered in 1957. City Council meets in regular session on the second Monday of each month and in caucus on the fourth Monday of every month. These meetings are held at the City Building, 739 Buttermilk Pike, beginning at 7:00 p.m. and are open to the public.

ADMINISTRATIVE STAFF: The City Clerk-Treasurer and Assistant City Clerk are responsible for budgets and tax bills, event planning and other administrative functions. Office hours are 9:00 a.m. - 5:00 p.m., Monday through Friday. Offices are located at 739 Buttermilk Pike, Crescent Springs, KY 41017.

CITY NEWS: The City publishes "The Crescent Springs Connection" four times a year. Newsletters are mailed out to all residents and businesses in the city. Check the website www.crescent-springs.ky.us and the LED signs for up to date information.

REAL ESTATE TAXES: The 2017 real estate tax rate is .221 for each \$100 of valuation assessed January 1, 2017. The tangible property tax rate is .158 for each \$100 of valuation assessed January 1, 2017. Tax bills are mailed by the end of September and are due on October 31st. If you do not receive your tax bill by October 1st contact the City Clerk's office at 859-341-3017.

PUBLIC Works: The Director of Public Works plus 3 full time employees and 3 part-time employees maintain 19 miles of streets, the Community Park, the Municipal Building, and the Public Works Garage. Contact Public Works at 859-344-0797 with any street repairs, street light outages or related problems. Garage hours are 8:00 a.m. - 4:30 p.m. at 801 Buttermilk Pike.

BUILDING AND ZONING: Any exterior work on your home that is not replacement work requires a building permit before work begins. For zoning questions contact Alan DePompei, Building and Zoning at 859-344-0797.

POLICE DEPARTMENT: The City contracts with the City of Erlanger for Police Services. For emergencies call 911. For non-emergency calls, officers can be reached at 859-727-2424. The Erlanger Police will check your home while you are away if you notify them before leaving and supply them with some necessary information. Go to www.friendshipcity.com for more information.

FIRE DEPARTMENT: The City contracts with the Crescent-Villa Fire Authority for fire and emergency medical services. The non-emergency phone number is 859-341-3840. For emergencies call 911. Their website address is www.csvfd.com.

COMMUNITY PARK: The Crescent Springs Community Park is located along Buttermilk Pike just before the intersection of Collins Road. The park offers a large playground area for children ages 6-12, a separate playground for children ages 2-5, a full length basketball court, walking trail, handicap-accessible playground, and a large covered common area. The two smaller shelters may be rented by contacting the City Building at 859-341-3017. Shelter rental is \$40 for residents, and \$80 for non-residents.

VETERAN'S MEMORIAL: The Kenton County Veteran's Memorial is located at the corner of Buttermilk Pike and Collins Road to honor our County's veterans who served and died for their country.

NORTHERN KENTUCKY 9/11 MEMORIAL: This Memorial was dedicated September 11, 2015 and includes a piece of steel from one of the Twin Towers integrated into a granite memorial honoring those who perished that day. It is located in the Park near the Veteran's Memorial.

CHURCHES: Crescent Springs Baptist Church, Crescent Springs Church of God, Crescent Springs Presbyterian Church, and St. Joseph's Catholic Church, are all located within the City.

BUSINESSES: There are a variety of businesses, large and small, close at hand. Restaurants, groceries, retail, health and beauty to name a few. A list of businesses can be found on the Business page of the City's website.

SCHOOLS AND DAY CARES: Crescent Springs is located in the Kenton County school district; served by Dixie Heights High School, Turkeyfoot Middle School and River Ridge Elementary. Local Private Schools are Covington-Catholic High School, Notre Dame Academy, Villa Madonna Academy, St. Joseph School, NKY Montessori Center, Rainbow Child Care Center, and Crescent Springs Early Learning Center.

LIBRARY: Kenton County Public Library offers books, e-books and various classes for young and old. The closest branch is right down the road at 401 Kenton Lands Road. Phone 859-962-4000 for information.

NEWSPAPER: The City is served by the daily Cincinnati Enquirer (Northern Kentucky Edition) and the weekly Community (Kenton County) Recorder. Call 800-876-4500 begin your subscription to the Enquirer, or 859-441-5537 for the Recorder.

HOSPITALS: St. Elizabeth South in Edgewood and St. Elizabeth Florence, and Christ Hospital Outpatient in Ft. Wright are located within 10 miles of the City. Bluegrass Urgent Care is located at 2327 Buttermilk Crossing.

WASTE COLLECTION/RECYCLING: Rumpke collects garbage every Monday, and recycling every Thursday. Red recycle bins are available at the City Building or Public Works Garage. Residents are billed individually by Rumpke. Call 859-472-7339 to set up this service. City ordinance prohibits the placing of trash cans curbside prior to 4:00 p.m. the day before scheduled pickup. Cans must be removed from the curb prior to 9:00 a.m. on the day following the scheduled pickup.

BUS SERVICE: Crescent Springs is served by the Transit Authority of Northern Kentucky (TANK). A Park and Ride lot is located at 2304 Buttermilk Crossing and schedules may be obtained at www.tankbus.org or by calling 859-331-TANK.

VOTING: To register to vote contact the Kenton County Voter Registration office at 859-392-1620. You can download a copy of the voter registration form at: <http://www.kentoncounty.org/countyclerk.html>.

UTILITIES: Gas and electric service is provided by Duke Energy (513-421-9500). Water service is supplied by the Northern Kentucky Water District (859-578-9898). Sanitary sewer service is provided by Sanitation District #1 (859-578-7450).

ANIMALS: All cats and dogs must be licensed with the County. Call the Kenton County Animal Shelter at 859-356-7400 for more information. The City has a "leash law" for dogs, and we also have a "pooper-scooper" law which applies to both cats and dogs.

POST OFFICES: The nearest post office is the Dixie Branch at 123 Buttermilk Pike in Lakeside Park. Phone number is 859-331-2175. Hours are posted on line.

DRIVERS LICENSE: Residents may go to either 230 Madison Pike, 2nd Floor in Covington or 1655 Delaware Crossing in Independence to renew their driver's license. For new license testing call 859-356-5925 at Independence for additional information.

VEHICLE REGISTRATION: Kenton County tags should be purchased within 15 days of purchase or relocating here. Registration can be done at 303 Court St. in Covington or 1655 Delaware Crossing in Independence. Go to the Kenton Co.
